REGULAR MEETING

Water Rates

Current rate is a base charge of \$3.96 per ERU. Rate increase will be effective on the September 2022 billing cycle.

LOST

There will be a meeting on September 13, 2022 at the Lula train depot regarding the LOST distribution. All cities in Banks County have been invited to attend the meeting to discuss the distribution amounts. Jerry Payne, Cliff Hill, and James Dumas will represent Homer at the meeting.

Homer representatives will also set up a meeting with Banks County Commissioners to discuss the LOST distribution amounts before July 21, 2022.

OLD BUSINESS

Subdivision Regulations

Adam Hazell, Georgia Mountain RDC representative, sent a revised Subdivision Ordinance to the Mayor and Council for review. Changes were discussed. Jerry Payne will relay the changes to Mr. Hazell so the corrections can be made to the ordinance. Changes include increasing the cul de sac from 80' to 100' (Section 5.6-12), changing the addressing system information from the Banks County Fire Department to the Banks County 911 center (Section 5.7-2), and omitting the wording "the above fees include the amount necessary to record the plat in the office of the Superior Court Clerk of Banks County" on the Appendix A Fee Schedule page.

James Dumas made the motion to approve the amended subdivision ordinance. Motion was seconded by Sandra Garrison and approved. (6-0)
